Hook and Newnham Basics Cricket Club is fully committed to safeguarding and promoting the wellbeing of all its colt members.

The Club believes that it is important that members, coaches, administrators, volunteers and parents associated with the Club should show respect not only to each other but also to those visiting the Club.

Any concerns or complaints that anyone has about any aspect of the Club should be shared with any of the following:

- All colt members must familiarise themselves with, and be guided by, the ethos of fair play and by the ECB's Spirit of the Game guidelines. Winning at all costs is not acceptable.
- All colt members must play within the rules of the game and respect managers and officials and their decisions both from HNBCC and from the opposition's Club.
- All colt members must respect the players in their team and those from the opposition and use correct and proper language at all times.
- All colt members should keep to agreed timings for training sessions and matches and inform their Team Manager if they are not able to keep to the timings.
- All colt members only come under the club's responsibility during their specified training times. U9 and U11 colts 17:45hrs - 18:45hrs on training nights and U13 and U15 colts between 19:00hrs - 20:00hrs.
- At matches colts remain the responsibility of parents, carers or other suitable adult. Coaches are involved in the match and therefore cannot be expected to supervise colts not currently participating in the game.
- All colt members must wear suitable kit for training and a set of whites for matches.
- Helmets must be worn by all colt members whilst batting/standing up to the wicket in all matches and practice sessions when a hard ball is in use.
- All colt members must pay the annual subscription promptly and any match fees on the day.
- All colt members are not allowed to smoke whilst representing the Club at any level.
- All colt members are not allowed to consume alcohol or take drugs of any kind whilst representing the Club at any level.
- All colt members are not allowed to use mobile phones in the changing room.
- The club strongly advises against placing images of other players/members on social networking sites.

<p>Your right to withdraw consent</p>	<p>Where you have given your consent to any processing of personal data, you have the right to withdraw that consent at any time. If you do, it will not affect the lawfulness of any processing for which we had consent prior to your withdrawing it.</p>

<p>How long we will keep your personal data for</p>	<p>We will not retain your personal data for longer than is reasonable and necessary for the purposes for which it was collected. We shall retain your personal data for such time as you are registered with HNBCC as a member. 2 years after you cease to be a member of HNBCC or play an active part in HNBCC, we shall delete your data.</p>
